Frequently used terms

Listed below are definitions of several of ExxonMobil's key business and financial performance measures and other terms. These definitions are provided to facilitate understanding of the terms and their calculation. In the case of financial measures that we believe constitute "non-GAAP financial measures" under Securities and Exchange Commission Regulation G, we provide a reconciliation to the most comparable Generally Accepted Accounting Principles (GAAP) measure and other information required by that rule.

- Capital and exploration expenditures (Capex)**

Represents the cost-based basis of additions at cost to property, plant and equipment, and intangible assets or other intangible assets from the consolidated statement of income. Expenditures include the value of intangible assets acquired in acquisitions, the value of intangible assets used in acquisitions, and depreciation on the cost of exploration, support equipment and facilities, including property, plant and equipment when acquired. While ExxonMobil management is responsible for all materials and elements of all projects, particular focus is placed on managing the controllable aspects of the group of expenditures.
- Cash operating costs and cash operating expenses (cash Opex, structural efficiencies, or structural reductions)**

Cash operating costs consist of (1) Production and manufacturing expenses, (2) Selling, general and administrative expenses, and (3) Exploration expenses, including by-liner from ExxonMobil's Consolidated statement of income. The sum of these income statement lines serve as an indicator of cash operating costs and do not reflect the total cash operating costs of the Corporation. Cash operating expenses are expenses for the business that include equity-creating cash expenses and which are considered material to management's oversight of spending over time. This measure is useful for investors to understand the Corporation's ability to generate cash through integrated expense management. - Returns, rate of return, IRR**

Unless referring specifically to internal rate of return, references to returns, rate of return, IRR, and similar terms mean future discounted cash flow returns on future capital investments based on current company estimates. Investment returns include gas exploration and acquisition costs.
- Heavy oil and oil sands**

Heavy oil, for the purpose of this report, includes heavy oil, ultra-heavy oil, and bitumen, as defined by the World Petroleum Congress ("WPC") based on American Petroleum Institute (API) gravity and viscosity at ambient conditions. Heavy oil has an API gravity between 10 and 21 degrees. The bit gravity of ultra-heavy oil and bitumen is less than 10 degrees. Ultra-heavy oil has a viscosity less than 10,000 centipoise, whereas the viscosity of bitumen is greater than 10,000 centipoise. The term "oil sands" is used to indicate heavy oil generally obtained that is associated in a mining operation.
- Project**

The term "project" can refer to a variety of different activities, and does not necessarily have the same meaning as in a government payment transparency report.
- Resources, resource base, and recoverable resources**

Along with certain reserves listed in this report, these refer to the total unassigned potential quantities of oil and gas that are expected to be ultimately recoverable. Expectations refer to known assessments and estimates of discovered resources as resource additions. The resource base includes quantities of oil and gas that are classified as proved reserves, as well as quantities that are not yet classified as proved reserves, but that are expected to be ultimately recoverable. The term "resource base" or similar terms are not intended to be compared to SEC definitions such as "provable" or "producible" reserves. The term "project" refers to those quantities of oil and natural gas estimates to be obtained from accumulations and includes recoverable and unrecoverable amounts.
