Recent Media Coverage ("Coverage") has had a substantial press impact and has of late become an all-pervasive part of the U.S. Securities and Exchange Commission (SEC) in connection with the solicitation of proxies for Equinor's 2021 Annual Meeting (the "Meeting, Proxy Solicitation"). Equinor has received a number of inquiries from investors and other parties in the context of proxy solicitation in respect of the 2021 Annual Meeting, including regarding the nature of Equinor's director and executive offices and their respective interests in Equinor, its security holdings or interests in stock in the Meeting Proxy Solicitation. To the extent knowledge of such information in Equinor's records are not reported, or have changed since the events described in the Meeting Proxy Solicitation, such changes have been reflected in the Statement of Financial Accounting in Form 10-K Statement of Changes in Ownership in Form 4 filed with the SEC. Details concerning the interests of Equinor's Board of Directors in relation to the 2021 Annual Meeting are contained in the Meeting Proxy Solicitation.
